ASSIGNMENT OF TRADEMARKS

ASSIGNOR will execute further papers and will take other action if necessary and proper to vest full title in and to the Marks in **ASSIGNEE**, or if necessary and proper for **ASSIGNEE** to obtain, register, renew or enforce the Marks.
