NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged,


1. Assignor does hereby sell, assign, transfer and set over to Assignee all right, title and interest in and to the Marks, together with the goodwill associated with the Marks;

Assignor further authorizes the commissioner of Patents and Trademarks of the United States and any official of any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Marks and title thereto as the property of the Assignee, its successors, legal representatives and assigns in accordance with the terms of this instrument.

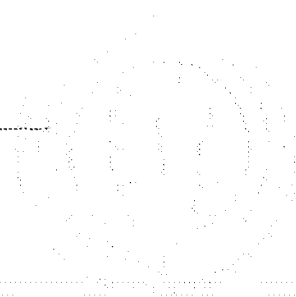
