SECURITY INTEREST ASSIGNMENT

THIS SECURITY INTEREST ASSIGNMENT ("Assignment") dated as of JANUARY 31, 2011 is by PEACHES UNIFORMS, INC., a Texas corporation ("Borrower"), with its principal office at 201 Regal Row, Dallas, TX 75247, in favor of THE FROST NATIONAL BANK, a national banking association, doing business as FROST CAPITAL GROUP, whose office address is at 2727 N. Harwood, 10th Floor, Dallas (Dallas County), TX 75201 (together with its successors and assigns, "Secured Party").

RECITALS

WHEREAS, Borrower and Secured Party are parties to (a) that certain SECURITY AGREEMENT dated as of even date herewith (as amended, modified or restated from time to time, the "Security Agreement"), and (b) that certain TRADEMARK COLLATERAL SECURITY AGREEMENT dated as of even date herewith (as amended, modified or restated from time to time, the "Trademark Security Agreement" and together with the Security Agreement, collectively, the "Security Agreements"), pursuant to which Borrower granted to Secured Party a security interest in all of Borrower's right, title and interest in certain Collateral (as defined in the Trademark Security Agreement) including the Trademark Licenses (as defined in the Trademark Security Agreement), the Trademarks (as defined in the Trademark Security Agreement) and associated registrations set forth in Schedule A attached hereto; and

WHEREAS, it is the purpose of this document to evidence the grant of the security interest in a form suitable for recording in the United States Patent and Trademark Office.






