**QUITCLAIM ASSIGNMENT AND RELEASE OF TRADEMARK
COLLATERAL ASSIGNMENT**

This agreement dated January 25, 2011, is by and between Conn-Selmer, Inc. ("Conn-Selmer"), successor in interest to Symphony Industries, Inc. ("Symphony") and GMAC Commercial Finance LLC ("GMAC"), successor in interest to BNY Financial Corporation ("BNY"). For good and valuable consideration, the receipt and sufficiency of which is acknowledged, the parties hereby agree as follows:

1. The parties confirm that the Trademark Collateral Assignment agreement between Symphony, predecessor in interest to Conn-Selmer, and BNY, predecessor in interest to GMAC, dated August 9, 1993, and recorded in the US Patent and Trademark Office at Reel/Frame 1022/0052 on August 20, 1993 (the "TCA Agreement"), was intended solely as a grant of a security interest in the trademarks as set forth in the TCA Agreement (the "Trademarks"), and not as an assignment of any ownership interest of any kind in the Trademarks.
2. To the extent that the TCA Agreement may be interpreted in any manner as a transfer or assignment of any ownership rights in the Trademarks from Symphony to BNY, to remove any doubt, GMAC hereby confirms that it currently holds no, and has not held in the past any, ownership rights of any kind in the Trademarks, other than a security interest, and that it quitclaims any such ownership rights.
3. GMAC hereby terminates the TCA Agreement and releases the security interest relating to the Trademarks, including those identified on Exhibit A hereto, and relinquishes to Conn-Selmer and its related entities the continuing security interest in and lien on the Trademarks and otherwise assigns, grants and conveys to Conn-Selmer and its related entities any and all rights GMAC may have in or to the Trademarks in order to vest in Conn-Selmer and its related entities full and unencumbered title to said Trademarks.

IN WITNESS WHEREOF, GMAC Commercial Finance LLC has caused this Release of Trademark Collateral Assignment to be executed by its duly authorized signatory this 25th day of JANUARY, 2011.
