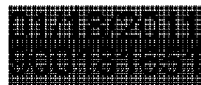

**WHEREAS**, Assignor is the owner of the federally registered trademark "CIVILIANAIRE", Registration No. 3868715 (the "Trademark"); and


