TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of January 28, 2011, is made by Bank of Montreal, as Administrative Agent (the "Secured Party"), in favor of Carolina Beer & Beverage, LLC (the "Grantor").


WHEREAS, the Secured Party has agreed to terminate and release its security interest in all of the Trademarks.
