PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Partial Release") is made as of January 31, 2011 (the "Effective Date") by **Deutsche Bank Trust Company Americas** ("DBTCA"), located at 60 Wall Street, New York, New York 10005, as collateral agent (in such capacity, together with its successors in such capacity, the "Collateral Agent") for the Secured Parties (as defined in the Credit Agreement referred to below), in favor of **Solutia, Inc.**, a Delaware corporation, located at 575 Maryville Centre Drive, St. Louis, Missouri 63141 (the "Borrower"), **CPFilms Inc.**, a Delaware corporation, located at 4210 The Great Road, Fieldale, Virginia 24089 ("CPFilms"), and **Flexsys America L.P.**, a Delaware limited partnership, located at 260 Springside Drive, P.O. Box 5444, Akron, Ohio 44333 ("Flexsys") (Borrower, CPFilms, and Flexsys, collectively, the "Grantors").

WHEREAS, reference is made to (i) that certain Credit Agreement dated as of March 17, 2010 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") by and among the Borrower, the Collateral Agent, DBTCA as administrative agent for the Lenders (as defined herein), the lending institutions from time to time party thereto (the "Lenders"), and the other parties thereto, and (ii) that certain Security Agreement dated March 17, 2010 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") entered into between Borrower, CPFilms, Flexsys, certain other subsidiaries of the Borrower, and the Collateral Agent for the benefit of the Secured Parties (capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Credit Agreement or the Security Agreement as the case may be);

WHEREAS, pursuant to the Security Agreement, Grantors executed and delivered to Collateral Agent that certain Trademark Security Agreement dated March 17, 2010 (the "Trademark Security Agreement") in favor of the Collateral Agent for the benefit of the Secured Parties;

WHEREAS, pursuant to the terms and conditions of the Trademark Security Agreement, Grantors pledged and granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in and to all of the right, title and interest of Grantors in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 7, 2010 at Reel/Frame 004181/0433; and

WHEREAS, Grantors have requested that Collateral Agent release its lien on and security interest granted pursuant to the Trademark Security Agreement in and to the Trademark Collateral pertaining solely to those certain Trademarks set forth on Schedule A hereto (the "Released Trademark Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Secured Parties and itself, hereby terminates, cancels and releases as of the Effective Date its lien on and security interest granted in and to the Released Trademark Collateral pursuant to the Trademark

Security Agreement and hereby assigns and transfers to the Grantors any right, title and interest it may have in, to and under the Released Trademark Collateral pursuant to the Trademark Security Agreement.

The release set forth herein shall be without recourse to or warranty by the Collateral Agent and shall relate solely to the Released Trademark Collateral.

THIS PARTIAL RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
