**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

This TERMINATION AND RELEASE is dated as of December 3, 2010, from CITIBANK, N.A., a national banking association located at 388 Greenwich Street, 14th Floor, New York, NY 10013, as trustee (the "Trustee"), to DD IP HOLDER LLC, a Delaware limited liability company (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Base Indenture, dated as of May 26, 2006, and the related transaction documents (the "Base Indenture"), a security interest (the "Security Interest") was granted by the Grantor to the Trustee to certain collateral, including the Trademark Collateral (as herein defined);

WHEREAS, the Security Interest granted by Grantor pursuant to the Base Indenture was recorded by the United States Patent and Trademark Office, Trademark Division, on May 30, 2006 at Reel 3318, Frame 0047;

WHEREAS, the Trustee now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Base Indenture, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Trustee hereby states as follows:

1. Definitions. The term "Trademark Collateral", as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the Base Indenture.

2. Release of Security Interest. The Trustee hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Trustee in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Trustee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
