RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, DrugTest, Inc., a Delaware corporation (d/b/a DISA, Inc.) (the “Company”) granted a security interest in and lien upon certain trademarks, trademark applications and other intellectual property rights to Silicon Valley Bank (“Bank”) as set forth in the Intellectual Property Security Agreement, dated as of September 29, 2003, by the Company in favor of Bank (the “Initial IP Security Agreement”) and the Addendum to Intellectual Property Security Agreement, dated as of January 30, 2006, by the Company in favor of Bank (the “Supplemental IP Security Agreement” and, together with the Initial IP Security Agreement, the “IP Security Agreements”);

WHEREAS, an executed copy of the Initial IP Security Agreement was recorded in the United States Patent and Trademark Office on November 7, 2003, at Reel 2862, Frame 0503;

WHEREAS, an executed copy of the Supplemental IP Security Agreement was recorded in the United States Patent and Trademark Office on March 8, 2006, at Reel 3311, Frame 0315; and

WHEREAS, the Company has requested that Bank release and reassign its interest in all trademarks, trademark applications and other intellectual property rights of the Company, including, but not limited to, all trademarks and trademark applications more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Bank hereby:

1. releases and conveys to the Company any and all liens, security interests, right, title and interest of Bank granted pursuant to the IP Security Agreements in all trademarks, trademark applications and other intellectual property rights of the Company, including all trademarks and trademark applications more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by the Company to Bank pursuant to or in connection with the IP Security Agreements is terminated; and
3. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.
