ASSIGNMENT OF U.S. TRADEMARK

AND WHEREAS, pursuant to the Plan of Arrangement, Assignee shall acquire the entire right, title and interest in, to and under the Marks and the registrations therefor.

NOW, THEREFORE, pursuant to and in accordance with the Plan of Arrangement, Assignor does hereby assign, transfer and set over to Assignee all its right, title and interest in, to and under said Marks and registrations therefor, together with the goodwill of the business symbolized by the Marks, and with the entire business of Assignor to which the Marks pertain; together with all rights and privileges granted and secured thereby, including the right to sue and recover for any past violation, said rights to be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by said Assignor if this Assignment had not been made. This Assignment shall be deemed effective as of this 1st day of January, 2011.

AND, said Assignor hereby covenants that it has full right to convey the entire interest herein assigned.
