**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of February 8, 2011, is made by AMERICAN CAPITAL, LTD. (as successor by merger to American Capital Financial Services, Inc.) (American Capital"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with that certain Credit Agreement, dated as of October 18, 2007 (as amended, restated, supplemented or otherwise modified from time to time, and together with all general security agreements, trademark security agreements, and copyright security agreements entered into in connection therewith or in connection with prior versions thereof, the "**Credit Agreement**"), among NIVEL HOLDINGS, LLC, NIVEL PARTS & MANUFACTURING CO., LLC, HT ELECTRIC ACQUISITION, LLC and IMC ACQUISITION, LLC. (collectively, the "**Borrowers**"), the other Credit Parties signatory thereto, American Capital, and the Lenders signatory thereto from time to time (each individually a "**Lender**," and collectively, the "**Lenders**"), the Lenders made credit extensions to the Borrowers;

WHEREAS, in connection with the Credit Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Borrowers and the Credit Parties granted security interests in certain intellectual property owned by the Borrowers and the Credit Parties including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and

WHEREAS, the Security Agreements were recorded in the United States Patent and Trademark Office or the United States Copyright Office on the dates and on the reels, frames and volumes set forth on Annex I hereto;

NOW THEREFORE, American Capital hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and American Capital hereby reassigns any and all such right, title and interest (if any) that American Capital may have in the Intellectual Property Collateral to the Borrowers and the Credit Parties, respectively.

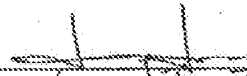
