## ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS AGREEMENT

This Agreement is made as of November 25, 2009 (the "Effective Date") by and between United IP, LLC, a company with an address at 3403 E John W Carpenter Fwy, Irving, Texas, 75062 ("UIP") and J. Kirston Henderson, an individual with an address at 1709 Ridgmar Blvd., Fort Worth, Texas, 76116

### ASSIGNMENT OF RIGHTS

WHEREAS, UIP is the owner, inventor, and/or author of Patents, Patent Applications, Trademarks, Trademark Applications, Copyrights, Domain Names, Trade Secrets, and UL Certifications, and Henderson is a private individual owed a sum of \$12,000 US by UIP.

NOW, THEREFORE, as payment in full of the debt owed by UIP to J. Kirston Henderson, the receipt of which is hereby acknowledged, UIP, agrees as follows:

1. GRANT AND ASSIGNMENT. UIP acknowledges and agrees that all Past Developments are owned by Assignee in the entirety: (a) in the case of copyrights, as "works made for hire" in which Assignee owns all copyright rights worldwide as the author, and (b) as the exclusive owner or assignee of all worldwide rights to the Developments, including, without limitation, all copyright rights to the extent a Development is deemed by governmental authority not to be a work made for hire.

Such rights include, but are not limited to: (i) all copyrights, patents, trademarks, trade secrets, design rights, utility model rights, in both print, electronic, and any other format, in all territories worldwide, via all distribution methods now and in the future, as well as (ii) any other rights for Assignee to exclusively reproduce, create derivative works, publicly distribute, publicly display, publicly perform, exercise all sound recordings rights (including, without limitation, all digital distribution, reproduction, and performance rights) and moral rights (including, without limitation, all rights to attribution and integrity), as well as practice, make, use, sell, have made and manufactured, have sold, offer for sale, design, reproduce, and improve the Developments and any new designs or derivations of the Developments, (iii) any Internet Domain Names, (iv) any pending patent and trademark applications, and (v) any UL certifications.

2. SECURING RIGHTS. I agree to take all steps at the request of Assignee to secure for Assignee all rights in the Developments and to protect Assignee's rights in the Developments. I appoint Assignee as my attorney-in-fact to enable Assignee to record, file and prosecute any application for, and acquire, maintain and enforce, any intellectual property rights and any other rights in the Developments throughout the universe in all languages and in all media and forms of expression and communication now or later developed, including, without limitation, all extensions, renewals and reissues. I waive any and all rights of attribution and integrity I may have in any of the Developments pursuant to Section 17 U.S.C. §106A(e) of the United States copyright laws.

3. ISSUANCE. I authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States, to issue patents or other evidence or forms of industrial property protection on applications to Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

I authorize and request the United States Copyright Office, and any official of any country or countries foreign to the United States, to issue copyright registrations, to Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

I authorize and request any Internet Domain Name Registrars managing Internet Domain Names owned by UIP to transfer those Internet Domain Names to Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

I authorize and request Underwriters Laboratory transfer any UL Certifications owned UIP to Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

4. REPRESENTATION. I represent that I have full right to convey the entire rights assigned, and that I have not executed, and will not execute, any agreement conflicting with this instrument.

5. SUCESSOR. In the event of the death of J. Kirston Henderson, the assigned intellectual property rights described in this document shall be transferred to J. Carl Henderson, notwithstanding any will and/or trust to the contrary.

IN WITNESS WHEREOF, the parties execute this Agreement as of the Effective Date. Each person who signs this Agreement below represents that such person is fully authorized to sign this Agreement on behalf of the applicable party.

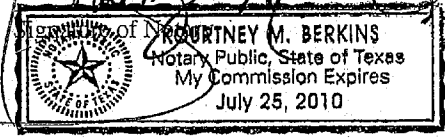

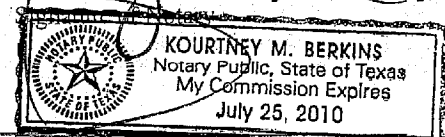
