TRADEMARK ASSIGNMENT

This VIRAGE LOGIC TRADEMARK ASSIGNMENT (this "*Assignment*") is made and entered into on September 2, 2010, effective prior to Virage Logic Corporation's conversion from a corporation to an LLC pursuant to the certificate of conversion filed on even date herewith with the Delaware secretary of state. This Assignment is made by and between those entities listed in the signature pages as assignors (collectively, the "*Assignors*") and Synopsys, Inc., a corporation organized and existing under the laws of the state of Delaware, USA ("*Assignee*").

WHEREAS, pursuant to that certain Agreement and Plan of Merger dated June 9, 2010 by and between Virage Logic Corporation ("*VIRL*") and Assignee, VIRL has caused to be assigned and/or agreed to cause to be assigned to Assignee, all right, title and interest in and to all of the trademarks, service marks, and trade names, together with the good will associated with and symbolized by them, as defined in the Agreement and Plan of Merger, including, without limitation, those trademarks, service marks, and trade names listed in Schedule 1 hereto (the "*Transferred Trademarks*");

WHEREAS, the Transferred Trademarks are currently owned by the Assignors, with different Assignors owning different trademarks, service marks, and trade names included in the Transferred Trademarks;

WHEREAS, all of the Assignors are owned or controlled by VIRL;

WHEREAS, the Assignors and Assignee desire to execute and record this Assignment, in order to effect and/or confirm the assignment of the Transferred Trademarks to Assignee.

NOW, THEREFORE, in consideration of the mutual covenants, agreements and understandings herein contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Each Assignor hereby assigns, transfers, conveys, and delivers to the Assignee and its successors and assigns, and the Assignee hereby purchases and accepts from each Assignor, all of its right, title, and interest in, to, and under the Transferred Trademarks, including, without limitation, all common law trademarks for which no applications or registrations exist, all applications to register any of the Transferred Trademarks, and all registrations that have been or may be granted for any of the Transferred Trademarks, together with all common law rights associated with the applications and registrations, and all goodwill associated with the Transferred Trademarks and symbolized thereby and that portion of the business which is ongoing and existing to which the trademarks pertain, together with the right to sue and recover damages for future, present, and past infringements of the Transferred Trademarks and to fully and entirely stand in the place of the Assignor in all matters related to the Transferred Trademarks.

2. Each Assignor agrees to execute and deliver such other documents and to take all such other actions which the Assignee, its successors and/or assigns may reasonably request to effect the terms of this Assignment, and to execute and deliver any and all affidavits,

testimonies, declarations, oaths, samples, exhibits, specimens, and other documentation as may be reasonably required to effect the terms of this Assignment and its recordation in relevant state and national trademark offices.






