GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS

January 27, 2011

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, THE KITCHEN COLLECTION, LLC, an Ohio limited liability company (successor by merger to The Kitchen Collection, Inc., a Delaware corporation) (the "Grantor") with principal offices at 71 East Water Street, Chillicothe, Ohio 45601, hereby grants to WELLS FARGO BANK, NATIONAL ASSOCIATION (successor by merger to Wells Fargo Retail Finance, LLC), as Collateral Agent, with offices at One Boston Place, 18th Floor, Boston, Massachusetts 02108 (the "Grantee"), a continuing security interest in (i) all of the Grantor's right, title and interest in, to and under to the United States trademarks, service marks, trademark registrations, service mark registrations, trademark applications (to the extent not constituting Excluded Property of the type described in clause (b) of the definition thereof set forth in the Security Agreement referred to below), and service mark applications (the foregoing, collectively, the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Security Agreement) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.




