TERMINATION OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

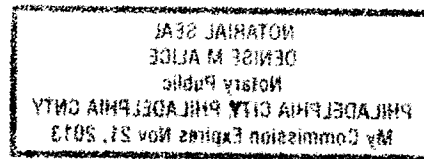

WHEREAS, BOSTON HERALD, INC., a Delaware corporation, HERALD INTERACTIVE, INC., a Delaware corporation, HERALD MEDIA HOLDINGS, INC., a Delaware corporation, and HERALD MEDIA, INC., a Delaware corporation (for itself and as successor by merger to NEWSPAPER SALES GROUP, INC.) (individually, a "Grantor", and collectively, the "Grantors"), had granted to WELLS FARGO BANK, NATIONAL ASSOCIATION (as successor by merger to WACHOVIA CAPITAL FINANCE CORPORATION (NEW ENGLAND)) (the "Secured Party"), a security interest (the "Security Interest") in the Grantors' trademarks and trademark applications (collectively, the "Trademarks") and the goodwill associated therewith pursuant to a certain Intellectual Property Security Agreement dated August 22, 2006 (the "Agreement"), which was filed at the United States Patent and Trademark Office on September 12, 2006 and recorded on Reel 3388, Frame 0089; and

WHEREAS, the Grantors have satisfied their obligations under the Agreement and the Secured Party has agreed to terminate the Security Interest.

NOW, THEREFORE, the Secured Party releases and discharges its security interest in, and reassigns to the Grantors, any and all interest in the Trademarks, including, without limitation, those listed on Schedule A attached hereto, together with the goodwill associated therewith. The Secured Party agrees that, upon request of the Grantors or any successor-in-interest or assignee thereof, and at the Grantors' expense, the Secured Party will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Grantors, or any successor-in-interest or assignee thereof, to effectuate the release of interests contemplated herein.

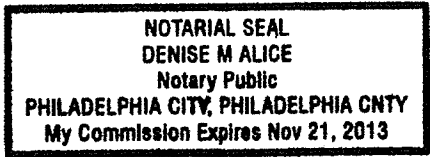
