## TRADEMARK AND DOMAIN NAME ASSIGNMENT

WHEREAS, the Assignor and Assignee now wish to effectuate the assignment of all right, title and interest in and to the Marks and the Domain Names from the Assignor to the Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor hereby assigns, transfers and sets over to the Assignee, all of Assignor's right, title, and interest in and to the Marks and the Domain Names, all registrations and pending applications therefor, and the goodwill of the business symbolized by the Marks and the Domain Names, including the right to sue for and receive all damages accruing from past infringement of the Marks or the Domain Names.

The undersigned agrees to take all actions and execute additional documents as is necessary to assign, transfer, perfect, and record the rights of Assignee in and to the Marks and the Domain Names.

This Assignment shall be binding on the parties, their successors and/or assigns, and all others acting by, through, with or under their direction, and all those in privity therewith.
