RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL

This RELEASE, dated as of May 17<sup>th</sup>, 2010, is made by MMV Financial Inc., as Lender ("MMV"), in favor of Sutus Inc. ("Sutus") as follows:

WITNESSETH

WHEREAS, pursuant to a Security Agreement between MMV and Sutus dated October 15, 2008 ("Security Agreement"), Sutus granted to MMV a security interest ("Security Interest") in all right, title and interest of Sutus in and to the Intellectual Property (as defined in the Security Agreement and including, without limitation, the intellectual property listed on Schedule A attached hereto). Capitalized terms used herein without definition are used as defined in the Security Agreement;

WHEREAS, the Security Agreement was recorded with the Canadian Intellectual Property Office on December 2, 2008 and with the United States Patent and Trademark Office on October 23, 2008;

WHEREAS, Sutus has requested that MMV release its security interest in all right, title and interest of MMV in and to the Intellectual Property and all applications therefor, technology and know-how, and all licenses, royalties and other monies relating thereto, set forth in Schedule A.

NOW, THEREFORE, MMV, without recourse, representation or warranty and at Sutus' sole cost and expense, hereby TERMINATES, RELEASES and DISCHARGES the Security Interest created by the Security Agreement in the Intellectual Property, and any right, title or interest of MMV therein shall hereby cease and become void.

MMV hereby authorizes Sutus, its legal counsel or their respective agents to prepare such documents and make such filings as necessary to give effect to the releases and discharges described herein.

MMV agrees to provide Sutus, its legal counsel or their respective agents with any information and additional authorization necessary to effect the release of such Security Interest.
