AN ARIZONA CORPORATION


1. The name of the corporation is REPUBLIC WESTERN INSURANCE COMPANY.
2. Article I is amended as follows:

ARTICLE I


The name of the corporation shall be REPWEST INSURANCE COMPANY.

3. The amendments were adopted by the sole shareholder of the Corporation on October 6, 2010, in the manner prescribed by the Arizona Business Corporation Act.
4. The number of shares outstanding and entitled to vote at the time of such adoption was 3,300,000 shares of common stock.
5. All 3,300,000 shares of common stock outstanding and entitled to vote on the adoption voted for the amendment. No share of stock voted against the amendment.
6. The amendment does not provide for an exchange, reclassification, or cancellation of issued shares.
7. The amendment does not effect a change for the corporation's stated capital.
