TERMINATION AND RELEASE OF SECURITY INTEREST

THIS TERMINATION AND RELEASE OF SECURITY INTEREST, dated as of February 7, 2011, (this "Termination and Release") is from RBC BANK (USA), having a mailing address of 75 Fifth Street NW, Suite 900, Atlanta, Georgia 30308, ("RBC"), in its capacity as Agent (together with its successors and permitted assigns) for itself and the Lenders, to SECUREWORKS, INC., having a mailing address of 11 Executive Park Drive NE, Atlanta, Georgia 30329, ("SecureWorks").

WITNESSETH:

WHEREAS, pursuant to the Loan and Security Agreement dated March 13, 2008 (including all annexes, exhibits or schedules thereto, and as amended, restated, supplemented or otherwise modified) by SecureWorks in favor of RBC (the "Prior Loan Agreement"), the Intellectual Property Security Agreement dated March 13, 2008 (including all annexes, exhibits or schedules thereto, and as amended, restated, supplemented or otherwise modified) by SecureWorks in favor of RBC (the "Prior IP Security Agreement"), the Amended and Restated Loan and Security Agreement dated May 22, 2009 (including all annexes, exhibits or schedules thereto, and as amended, restated, supplemented or otherwise modified) by SecureWorks in favor of RBC (the "Loan Agreement"), and the Amended and Restated Intellectual Property Security Agreement dated May 22, 2009 (including all annexes, exhibits or schedules thereto, and as amended, restated, supplemented or otherwise modified) by SecureWorks in favor of RBC (the "IP Security Agreement"), a security interest (the "Security Interest") was granted by SecureWorks to RBC in the Intellectual Property Collateral;

WHEREAS, the IP Security Agreement was recorded on June 3, 2009 with the Assignment Division of the United States Patent and Trademark Office at Reel 022773, Frame 0009 and at Reel 003998, Frame 0453; and

WHEREAS, RBC now desires to terminate and release the entirety of its Security Interest in the Intellectual Property Collateral.


NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Intellectual Property Collateral pursuant to the Prior Loan Agreement, the Prior IP Security Agreement, the Loan Agreement, and the IP Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, RBC hereby states as follows:

1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Prior Loan Agreement, the Prior IP Security Agreement, the Loan Agreement, and the IP Security Agreement.

2. Release of Security Interest. RBC hereby terminates, releases and discharges its Security Interest in the Intellectual Property Collateral, including (i) the Patents listed in Exhibits 1 and 2 attached hereto and (ii) the Trademarks listed in Exhibits 3 and 4 attached hereto. Any and all right, title or interest of RBC in the Intellectual Property Collateral and all proceeds thereof, including without limitation the goodwill of the business connected with the use of, and symbolized by, the Intellectual Property Collateral and any and all causes of action which may exist by reason of infringement of the Intellectual Property Collateral shall hereby cease and become void.
