**ARTICLES OF AMENDMENT  
TO THE

2. The Amendment recommended to the shareholders by the Board of Directors and duly adopted by the Shareholders of Fun Express, Inc. is as follows:

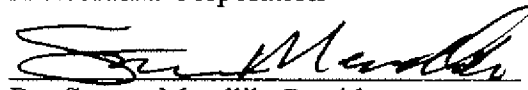
ARTICLE I
