DEED OF ASSIGNMENT

THIS DEED made and entered into between:

RINEER HYDRAULICS, INC.

a corporation that organized and existing under the laws of the State of Texas, United States of America, (hereinafter called the ASSIGNOR) of the first part;

and

BOSCH REXROTH CORPORATION

a corporation organized and existing under the laws of the State of Pennsylvania, United States of America, located at 5150 Prairie Stone Parkway, Hoffman Estates, IL 60192, United States of America, (hereinafter called the ASSIGNEE) of the second part.

WHEREAS:-

- (1) The ASSIGNOR is the registered owner in the United States of America of the trademark **RINEER**, Reg. No. 2,073,235 (hereinafter called the said trademark).
- (2) The ASSIGNOR and the ASSIGNEE have agreed to the assignment of the said trademark together with the registration thereof in the United States of America in favor of the ASSIGNEE.

NOW THEREFORE IT IS AGREED AS FOLLOWS:-

For good and sufficient cause, and in consideration of the sum of U.S.\$1.00, the ASSIGNOR does hereby assign and transfer unto the ASSIGNEE all rights of ownership in and to the said trademark and registration thereof, as well as all rights and privileges relating thereto and corresponding therewith, and the right to sue for any past infringement of the mark and registration thereof, including the goodwill of the business symbolized by the mark and to which the mark appertains, with no exception of any kind, so that from this day on the ASSIGNEE may consider itself as the sole owner of the said trademark and registration thereof, and may exploit it as its own or make any arrangements that best suit its interests; and the ASSIGNOR shall have no further claim to the trademark in any case or at any time. This assignment is made nunc pro

tunc as of December 31, 2010.
