WHEREAS, Wolf-Garten, of North America, LP, a limited partnership of the state of Delaware (hereinafter "WGNALP") was the owner of the entire right, title, and interest in and to the following trademark and the United States Registration thereof:

WHEREAS, prior to September 5, 2009, WGLP and WGM were both dissolved and pursuant to said dissolution, WGNALP duly sold, assigned, and transferred the entire right, title, and interest in and to the above trademark, said registration and all goodwill of the business in connection with which said trademark was used together with all rights and privileges pertaining to said trademark to WGKG; and


WHEREAS, WGNALP and WGM desire to affirm said assignment in a form appropriate for recording in the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of the premises and the sum of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, WGNALP has sold, assigned, and transferred and does hereby sell, assign, and transfer unto WGKG, its successors and assigns, the entire right title, and interest in and to said trademark and said registration, including all goodwill of the business in connection with which said trademark is used, together with all rights and privileges pertaining to said trademark, including the right to obtain renewals of said registration thereof for subsequent terms, the same to be held and enjoyed by WGKG, its successors and assigns as fully as the same would have been held and enjoyed by WGNALP had this sale, assignment, and transfer not been made.



AGREED to by the undersigned acting in their representative capacities for the parties in the dissolution and winding up of WGNALP and WGM respectively.


