**THIRD:** The amendment of the Certificate of Incorporation of the corporation effected by this certificate of amendment is to change the name of the corporation.

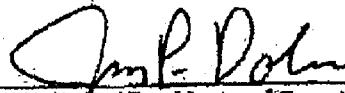
