RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT of Trademarks dated February 17, 2011 by OLD SECOND NATIONAL BANK, as Secured Party (the "*Secured Party*") as hereinafter described, with its main office and mailing address at 37 S. River Street, Aurora, Illinois 60506;

WITNESSETH:

WHEREAS, Allen Brothers, Inc., an Illinois corporation, with its mailing address and principal place of business at 3737 South Halstead Street, Chicago, Illinois 60609, The Great Steakhouse Steaks LLC, an Illinois limited liability company, with its mailing address and principal place of business at 3801 South Sangamon Street, Chicago, Illinois 60609 (collectively, the "*Debtors*"), and the Secured Party were parties to a certain trademark collateral agreement dated October 29, 2009 between the Debtors and the Secured Party which was recorded in the United States Patent and Trademark Office on November 10, 2009 at Reel 4093, Frame 0909 (the "*Agreement*"), pursuant to which the Debtors granted to the Secured Party, a security interest in and collateral assignment of the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and

WHEREAS, the Debtors have requested that the Secured Party release its security interests in the Trademark Property and reassign the same to the Debtors;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Secured Party hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Debtors, without any representation, warranty, recourse or undertaking by the Secured Party, all of its right, title and interest, if any, in and to:

(i) Each trademark, trademark registration and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) All proceeds of the foregoing, including without limitation any claim by any Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
