**DOMAIN NAME AND TRADEMARK  
TRANSFER AGREEMENT**

1. Assignment of Marks

ASSIGNOR hereby assigns to ASSIGNEE all of its right, title and interest in and to the following trademarks (including service marks and other marks) (“Marks”), including the goodwill of the business associated with and symbolized by the Marks, and all rights in any registrations or applications for registration for the Marks and including any and all claims for past infringement thereof, including all rights as opponents in any opposition or cancellation proceeding. For purposes of recording this assignment with the U.S. Patent and Trademark Office (“PTO”) or other reasonable purposes, ASSIGNOR agrees to execute further documentation and instruments as reasonably requested by ASSIGNEE.

(b) This assignment affects title by transferring title completely to ASSIGNEE.



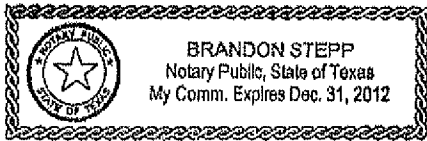
