ASSIGNMENT OF TRANSFERRED INTELLECTUAL PROPERTY

THIS ASSIGNMENT OF TRANSFERRED INTELLECTUAL PROPERTY (the "Assignment") is made, executed and delivered as of December 18, 2009, by and among, COPPER MOUNTAIN, INC., a Delaware corporation ("CMI"), CMH CORPORATION, a Colorado corporation ("CMH"), WHEELER JUNCTION ELECTRIC COMPANY, a Colorado corporation ("Wheeler"), COPPER MOUNTAIN REAL ESTATE, INC., a Colorado corporation ("CMREI") (CMI, CMH, Wheeler and CMREI, collectively "Assignor"), and POWDR CORP., a Delaware corporation ("Powdr") and POWDR - COPPER MOUNTAIN LLC, a Delaware limited liability company ("Assignee"), under the following circumstances:

BACKGROUND:

This Assignment is being executed and delivered pursuant to that certain Asset Purchase Agreement by and between Assignor and Powdr Corp., a Delaware corporation ("Powdr") dated as of November 5, 2009, as amended ("Purchase Agreement"). Pursuant to that certain Assignment and Assumption of Asset Purchase Agreement dated as of December 17, 2009, Powdr assigned to Assignee and certain other affiliated entities (together with Assignee, the "Powdr Affiliates"), and the Powdr Affiliates assumed, all of Powdr's right, title and interest in and to the Purchase Agreement. All initially capitalized terms used but not otherwise defined in this Assignment shall have the meanings assigned to such terms in the Purchase Agreement.

NOW, THEREFORE, in consideration of the mutual promises contained in this Assignment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns to Assignee all of its right, title and interest in, to and under the Transferred Intellectual Property, including, without limitation, the Transferred Intellectual Property described in **Exhibit A** attached hereto, including but not limited to, all goodwill relating thereto, and in the case of the pending applications, the goodwill of the business symbolized by the marks, and the identified applications therefore as part of the entire business or portion thereof to which the marks pertain as required by 15 U.S.C. § 1060, together and all pending or inchoate causes of action or claims related to any of the foregoing, including the right to sue and recover for past infringement or breaches of contract.

2. Assignee hereby accepts this assignment and agrees to be bound by all of the terms, covenants and conditions arising or accruing in connection with the Transferred Intellectual Property on the Assignor's part to be performed and Assignee and Powdr both do hereby jointly and severally assume all obligations of Assignor arising or to be performed by Assignor in connection with the Transferred Intellectual Property from and after the date hereof or as otherwise included in the Assumed Liabilities.

3. This Assignment may be executed in one or more counterparts, and each signatory hereto may sign on a separate counterpart, each of which shall be deemed an original and all of which, when taken together, shall constitute one instrument. Signature pages may be

detached from the counterparts and attached to a single copy of this Assignment to physically form one document. Facsimile signature pages will be acceptable and shall be conclusive evidence of execution.






