TRADEMARK ASSIGNMENT

This Trademark Assignment is made as of February 11, 2011 (the “**Effective Date**”) by and between **SAINTSBURY LLC**, a California limited liability company, having an address at 1500 Los Carneros Avenue, Napa, CA 94559-9742 (“**Assignor**”) and **GARNET VINEYARDS LLC**, a California limited liability company, having an address at 855 Bordeaux Way, Ste. 100, Napa, CA 94558-7565 (“**Assignee**”).

Whereas, Assignor and Plata Wine Partners LLC (“**PWP**”), an affiliate of Assignee, are parties to that certain Purchase and Sale Agreement dated January 31, 2011 (“**Purchase Agreement**”) pursuant to which Assignor has agreed to sell to PWP the trademark “**GARNET**” for “**wine**” as more fully identified in Schedule A attached hereto (the “**Garnet Mark**”).

PWP has assigned its rights to purchase the Garnet Mark to Assignee, pursuant to that certain assignment by and between PWP and Assignee dated as of February 11, 2011.

Now, therefore, pursuant to the terms and conditions of the Purchase Agreement, Assignor, for valuable consideration, the receipt and adequacy whereof are acknowledged, hereby assigns and transfers to Assignee, and Assignee hereby accepts:

A. All rights, title and interest held by Assignor in and to the Garnet Mark, the associated goodwill and the registration for the Garnet Mark as more fully identified in Schedule A, attached hereto; and

B. All rights to damages or profits, due or to become due, accrued or to accrue, arising out of past, present, or future infringement of the Garnet Mark or injury to said goodwill, together with the right to sue or recover the same.

This Trademark Assignment shall be construed, performed and enforced in accordance with, and governed by, the laws of the State of California, without giving effect to the principles of conflicts of laws thereof.

In the event that any provision of this Trademark Assignment shall be construed to conflict with a provision of the Purchase Agreement, the provision in the Purchase Agreement shall be deemed controlling. Assignee agrees to comply with and perform the obligations of PWP under the Purchase Agreement related to the Garnet Mark and this Trademark Assignment.
