

## TRADEMARK ASSIGNMENT

This Trademark Assignment, made this 25<sup>th</sup> day of January, 2011, by and between Peter-Christoph Haider, an individual, located at Stepbergweg 5, Grainau, Federal Republic of Germany 82491, (hereinafter referred to as "<u>HAIDER</u>") and GROUPION LLC, a California limited liability company, located at 400 Florence Street, Palo Alto, California (hereinafter referred to as "<u>GROUPION</u>");

WHEREAS, HAIDER has adopted, used, is using and is the owner of all right, title and interest in and to the trademark "GROUPION", U.S. Registration No. 3, 816,266, both for goods and services in the field of computer software and related services (the "<u>Trademark</u>") and

WHEREAS, GROUPION is desirous of acquiring all of HAIDER'S rights, title and interest in and to the Trademark, including but not limited to the Registration, any pending application, any common law or other unregistered rights in the Trademark, and the goodwill of the business symbolized by the Trademark (the "Goodwill");

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

- 1. HAIDER hereby assigns unto GROUPION, free and clear of all known encumbrances, any and all right, title and interest throughout the world in and to the Trademark, the Registration, any pending application, any common law or other unregistered rights in the Trademark, and the Goodwill, including all causes of action (either in law or in equity) and the right to sue, counterclaim and recover for past, present and future infringement of the rights assigned under this Assignment.
- 2. HAIDER represents that there are no third party claims against the Trademark, that the information in the Registration is true and correct; that it has not granted any licenses in regard to the Trademark and that it is not subject to any liens. HAIDER agrees to indemnify and hold harmless GROUPION from and against any claims, losses or damages, including reasonable attorney's fees, arising from or related to a breach of any of the representations made herein or from HAIDER'S use of the Trademark prior to the date of this Assignment.
- 3. In order to give full force and effect to the assignment granted herein, HAIDER agrees to reasonably cooperate (without additional cost or liability) with GROUPION in recording with appropriate state and federal Trademark Offices documents necessary to evidence the assignment granted herein.
- 4. The possession by HAIDER of the Trademark is transferred as of the Effective Date of this Assignment as provided herein.
- 5. This Agreement shall be binding on the successors and assigns of HAIDER and GROUPION.
  - 6. This Agreement shall be governed by the laws of the State of California.
