**RELEASE OF  
SECURITY INTEREST IN U.S. TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS, dated as of February 17, 2011 (this "Release"), is made and entered into by PNC Bank, National Association, as Agent for the Lenders (as hereinafter defined) under that certain First Amendment to Patent and Trademark Security Agreement, dated August 4, 2005 (the "Agreement"), made by ATI Properties, Inc., a Delaware corporation (the "Grantor") in connection with that certain First Amended and Restated Revolving Credit and Security Agreement, dated August 4, 2005, among the Grantor, Oregon Metallurgical Corporation, an Oregon corporation, Allegheny Ludlum Corporation, a Pennsylvania corporation, TDY Industries, Inc., a California corporation, ALC Funding Corporation, a Delaware corporation, Jessop Steel Company, a Pennsylvania corporation, Jewel Acquisition, LLC, a Delaware limited liability company, ATI Funding Corporation, a Delaware corporation and Jessop Steel Acquisition, LLC, a Pennsylvania limited liability company, the Guarantors (as defined in the Credit Agreement), PNC Bank, National Association ("PNC Bank"), JPMorgan Chase Bank ("JPMorgan") and various other financial institutions from time to time (PNC Bank, JPMorgan and such other financial institutions are each a "Lender" and collectively, the "Lenders"), PNC Bank, as administrative and collateral agent for the Lenders (in such capacity, the "Agent"), Bank of America, N.A., National City Business Credit, Inc. and Wachovia Bank, National Association, as documentation agents for the Lenders, and PNC Capital Markets, Inc. and J. P. Morgan Securities, Inc. as co-lead arrangers and joint book runners (as amended, modified or supplemented from time to time, the "Credit Agreement").

Capitalized terms used herein and not otherwise defined herein shall have the meanings assigned thereto in the Credit Agreement.

WHEREAS, pursuant to the Agreement, the Grantor granted to the Agent a Lien on all of such Grantor's right, title and interest in and to the registered Trademarks set forth on Exhibit A attached hereto and made a part hereof (the "Trademarks"), recorded August 15, 2005 in the United States Patent and Trademark Office, at Reel/Frame: 003174/0660:

WHEREAS, the Agent has agreed to release, relinquish and discharge its right, title and interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby releases, relinquishes and discharges in its entirety any and all Lien or security interest it has in the Trademarks; All rights to such Trademarks hereby revert to the Grantor.

2. The Agent hereby agrees, at the expense of the Grantor, to take any reasonable actions and to execute any further documents necessary or reasonably requested by the Grantor to effectuate, record or evidence the release of the Agent's security interest in such Trademarks, as applicable.

3. The Agent authorizes and requests the United States Patent and Trademark Office to record this Release against such Trademarks, as applicable.

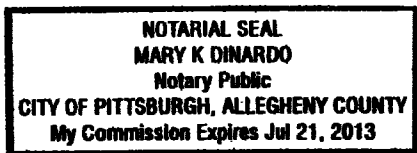
