**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of February 28, 2011 from GE BUSINESS FINANCIAL SERVICES INC. (f/k/a MERRILL LYNCH BUSINESS FINANCIAL SERVICES INC.), a Delaware corporation, located at 500 West Monroe Street, Chicago, IL 60601, as Administrative Agent (the “Grantee”) for certain banks and other financial institutions (the “Lenders”), to FESTIVAL FUN PARKS, LLC, a Delaware limited liability company (the “Borrower”), SmartParks – Riverside, Inc., a Delaware corporation (“Riverside”), Raging Waters Group, Inc., a California corporation (“Raging Waters”), and SmartParks – Florida, Inc., a Delaware corporation (together with Borrower, Riverside and Raging Waters, each a “Grantor” and collectively the “Grantors”).

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, dated as of February 6, 2008, among the Borrower, the other Grantors, and the other Lenders party thereto (as amended, restated, reaffirmed, supplemented or otherwise modified from time to time, the “Credit Agreement”), the Lenders agreed to extend credit to Borrower subject to the terms and conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, the Grantors entered into a Security Agreement, dated as of February 6, 2008 (as amended, restated, reaffirmed, supplemented or otherwise modified from time to time, the “Security Agreement”), for the benefit of the Secured Parties;

WHEREAS, pursuant to the Security Agreement, a security interest (the “Security Interest”) was granted by the Grantors to the Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of February 20, 2008, among the Grantee, the Borrower and the other Grantors (the “Security Agreement”), Grantors, by reference to the Security Agreement, reaffirmed their intent to grant a Security Interest to the Grantee specifically in the Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on February 21, 2008 at Reel 003725 and Frame 0860; and

WHEREAS, the Grantee now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Grantee hereby states as follows:


1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademarks, including those listed on Schedule A hereto. The term "Trademarks" shall have the meaning provided by reference in the Security Agreement.

2. Release of Security Interest. The Grantee hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Grantee in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
