**ASSIGNMENT AND ASSUMPTION OF TRADEMARK  
CRIME SCENE CLEAN -UP**

This Assignment and Assumption of Trademark Crime Scene Clean-Up (the "Assignment") is made effective as of this 15 day of February, 2011, by and between **CRIME SCENE CLEAN-UP, INC. AND LOUISE BURKHARDT**, (collectively the "Assignor") and **AA SCENE CLEAN, LLC AND JOHN H. TYLER** (collectively the "Assignee")

WITNESSETH:

Assignor is the registered owner of the Trademark "Crime Scene Clean-Up" bearing Serial Number 75206985 with the United States Patent and Trademark Office ("Property").

The parties hereto entered into an Asset Purchase Agreement for the sale/purchase of the Property on or about February 15, 2011, ("Asset Purchase Agreement") pursuant to which Assignor has agreed to assign all its rights, title, interests and appurtenances to Assignee.

As a condition of the Asset Purchase Agreement, the parties are to execute a Bill of Sale dated even date herewith for the purposes of conveying the Assignor's interest in the Property to the Assignee.

The parties hereto are entering into this Assignment in addition to the Bill of Sale for the purposes of providing additional documentation to United States Patent and Trademark Office for the assignment of the Property from the Assignor to the Assignee.

Assignor and Assignee desire to evidence their understanding of the assignment and assumption of the Property pursuant to the terms and conditions contained in the Asset Purchase Agreement, the Bill of Sale dated even date herewith and herein for the purposes of vesting all of Assignor's rights, title, interest and appurtenances as registered owner of the Property unto the Assignee.

NOW, THEREFORE, in consideration of the covenants and agreements contained in this Assignment and other good and valuable consideration, and intending to be legally bound, Assignor and Assignee agree as follows:

1. Assignment. As of the date of this Assignment, Assignor hereby assigns, transfers and sets over to Assignee, all right, title and interest of Assignor in and to the Property. Any special rights of the Assignor as the original owner of the Property is hereby assigned, transferred and set over to the Assignee.

2. Assumption. As of the date of this Assignment, Assignee hereby assumes, and agrees to be bound by, all of the covenants, agreements and obligations of Assignor as the owner of the Property. Assignee hereby assumes and to be bound by any and all special rights of the Assignor as the original owner of the Property.

3. United States Patent and Trademark Office. This Assignment is being entered into for the purposes of the United States Patent and Trademark Office transferring the Property from the Assignor to the Assignee. This Assignment shall authorize the Assignee to execute any documents of United States Patent and Trademark Office for the purposes of transferring the Property from the Assignor to the Assignee and shall serve as a limited Power of Attorney for the purposes contained herein and the Asset Purchase Agreement.

4. Assignor's Representations. This Assignment shall be construed under the terms and provisions of the Asset Purchase Agreement, the terms of which are incorporated herein by reference and survive the execution and delivery of this instrument. Nothing contained herein is intended to enlarge or diminish the covenants, representations and warranties contained in the Asset Purchase Agreement, which representations and warranties shall survive the execution and delivery of this Assignment as set forth in the Asset Purchase Agreement.


5. Binding Effect. This Assignment shall inure to the benefit of, and be binding upon, each of the parties hereto and their respective successors and assigns.
