EXECUTION COPY

THIS TRADEMARK SECURITY AGREEMENT, dated as of February 18, 2011, is made by each of the entities listed on the signature pages hereof (each a "Credit Party" and, collectively, the "Credit Parties"), in favor of General Electric Capital Corporation ("GECC"), as agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, "Working Capital Agent"), and accepted and agreed to by GA Capital, LLC, as agent for the Term B Lenders (in such capacity, together with its successors and permitted assigns, "Term B Agent", and together with Working Capital Agent, collectively, the "Agents").

WITNESSETH:

WHEREAS, pursuant to the Senior Secured, Super-Priority Debtor-in-Possession Credit Agreement, dated as of February 16, 2011 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Borrowers, each other Credit Party that is a party thereto, the Lenders party thereto, Working Capital Agent and Term B Agent, the Lenders have severally agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, each Credit Party is a debtor-in-possession in the Chapter 11 Cases (as defined in the Credit Agreement) and wishes to continue to operate its businesses and manage its properties as a debtor and debtor-in-possession pursuant to Sections 1107(a) and 1108 of the Bankruptcy Code (as defined in the Credit Agreement);

WHEREAS, each Credit Party has agreed, pursuant to a Guaranty and Security Agreement of even date herewith in favor of Working Capital Agent (as such agreement may be amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement"), to guarantee the Obligations (as defined in the Credit Agreement) of each Borrower;

WHEREAS, all of the Credit Parties are party to the Guaranty and Security Agreement pursuant to which the Credit Parties are required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Lenders and the Agents to enter into the Credit Agreement and to induce the Lenders to make their respective extensions of credit to the Borrowers thereunder, each Credit Party hereby agrees with the Agents as follows:

Section 1. Defined Terms. Capitalized terms used herein without definition are used as defined in the Guaranty and Security Agreement.

Section 2. Grant of Security Interest in Trademark Collateral. Each Credit Party, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of such Credit Party, hereby mortgages, pledges and hypothecates to Working Capital

Agent for the benefit of the Secured Parties, and grants to Working Capital Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of such Credit Party (the "Trademark Collateral"):

(a) all of its Trademarks and all IP Licenses providing for the grant by or to such Credit Party of any right under any Trademark, including, without limitation, those referred to on Schedule 1 hereto;

(b) all renewals and extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof;

provided, however, for the avoidance of doubt, the Trademark Collateral shall not include any assets or property of such Credit Party excluded from the definition of "Collateral" in the Guaranty and Security Agreement.

Section 3. Guaranty and Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to Working Capital Agent pursuant to the Guaranty and Security Agreement and each Credit Party hereby acknowledges and agrees that the rights and remedies of Working Capital Agent (for the ratable benefit of the Secured Parties) with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Guaranty and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

Section 4. The Order. The security interest provided for in this Trademark Security Agreement has also been granted pursuant to the Interim Order (or Final Order, when applicable). This Trademark Security Agreement supplements the Interim Order (or Final Order, when applicable) without in any way diminishing or limiting the effect of the Interim Order (or Final Order, when applicable) or any Lien or security interest granted thereunder.

Section 5. Credit Party Remains Liable. Each Credit Party hereby agrees that, anything herein to the contrary notwithstanding, such Credit Party shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with their Trademarks and IP Licenses subject to a security interest hereunder.

Section 6. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.

Section 7. Governing Law. This Trademark Security Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.






