**RELEASE OF FIRST LIEN SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of February 24, 2011, is made by **CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH** (f/k/a Credit Suisse, Cayman Islands Branch), as Administrative Agent and Collateral Agent (collectively, the "**Agent**"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

**WHEREAS**, in connection with that certain Credit Agreement, dated as of March 31, 2006 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among **FIBERVISIONS CORPORATION**, a Delaware corporation (f/k/a FiberVisions Delaware Corporation), **SPG/FV INVESTOR LLC**, a Delaware limited liability company, **FIBERVISIONS A/S**, a private limited company organized under the laws of the Kingdom of Denmark, the Agent, and the Lenders signatory thereto from time to time (each individually a "**Lender**," and collectively, the "**Lenders**"), the Lenders made credit extensions to the Borrowers;

**WHEREAS**, in connection with the Credit Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), **FIBERVISIONS, L.P.** (the "**Assignor**") and the Loan Parties granted security interests (the "**Security Interests**") in certain collateral, including the Intellectual Property Collateral (as hereinafter defined) owned by the Assignor and/or Loan Parties; and

**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto; and

**WHEREAS**, the Agent now desires to terminate and release the entirety of its Security Interest in the Intellectual Property Collateral.

**NOW THEREFORE**, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Intellectual Property Collateral pursuant to the Security Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby states as follows:

1. Definitions. The term "**Intellectual Property Collateral**," as used herein, shall mean all of the Assignor's and/or Loan Parties' rights, title and interest to and under the following, in each case whether now owned or existing or hereafter acquired or arising and wherever located (including, without limitation, those items listed on Annex II attached hereto);

(a) all of its Patents, and Trademarks, including, without limitation, those referred to on Annex II;

(b) as applicable, all renewals and extensions of the foregoing and all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(d) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Release of Security Interest. The Agent hereby terminates, **RELEASES**, and discharges, without representation, recourse or warranty whatsoever, all of its Security Interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Intellectual Property Collateral to the applicable Assignor or Loan Parties and any such right, title or interest shall hereby cease and become void.

3. Further Assurances. The Agent agrees, at the Assignor's and Loan Parties' expense, to cooperate with the Assignor and Loan Parties and to provide the Assignor and Loan Parties with any other information and additional authorization (including, without limitation, duly executing, acknowledging, procuring and delivering any further documents) reasonably required or desirable to effect the release of the Agent's Security Interests in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
