GRANT OF SECURITY INTEREST
IN PATENTS AND TRADEMARKS**

WHEREAS, INLET TECHNOLOGIES, INC., a Delaware corporation (the "Pledgor"), with offices at 1121 Situs Court, Raleigh, North Carolina 27606, is the owner of the patents listed on Schedule A attached hereto, which patents are registered or have pending applications in the United States Patent and Trademark Office (or the appropriate registry or filing office in the applicable country in which such patents are registered or applications are pending) as set forth on Schedule A attached hereto (all such patents, registrations and applications, collectively, the "Patents"); and the Pledgor is the owner of the trademarks and service marks listed on Schedule A attached hereto, which marks are registered or have pending registrations in the United States Patent and Trademark Office (or the appropriate registry or filing office in the applicable country in which such marks are registered or registrations are pending) as set forth on Schedule A attached hereto (all such trademarks, service marks, registrations and applications, collectively, the "Trademarks"); and

WHEREAS, in order to secure certain indebtedness, the Pledgor entered into a Security Agreement dated as of October 10, 2007, (as amended, modified, restated or supplemented from time to time, collectively the "Security Agreement"), in favor of Capitol Broadcasting Company, Inc., Core Capital Partners II-S, L.P., Core Capital Partners Fund II, L.P., Technology Venture Partners, L.P., TVP Affiliates Fund, L.P., TDFUNDII, L.P., Douglas Family Limited Partnership, Ronald C. Duff and Peter Cresse (collectively, the "Lenders"), and pursuant thereto executed and delivered an Intellectual Property Security Agreement as recorded in the United States Patent and Trademark Offices in Reel 020034 at Frame 0419 (Patents) and Reel 03648 at Frame 00010 (Trademarks) (the "Short-Form Security Agreement") pursuant to which the Pledgor granted to the Lenders, according to the terms of the Security Agreement, a security interest in all of its right, title and interest in and to the Trademarks and the Patents;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lenders do hereby release and relinquish, and do hereby reassign to the Pledgor, without representation or warranty, all of the Lenders' right, title and interest in and to the Patents and Trademarks listed on the attached Schedule A, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Patents and Trademarks, and do hereby agree that the filing of the Short-Form Security Agreement in the United States Patent and Trademark Office as aforesaid may be removed of record.




