**PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Release") is made as of March 3, 2011 (the "Effective Date") by Bank of America, N.A., as collateral agent (in such capacity, the "Collateral Agent") for the benefit of Hercules Incorporated (the "Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of March 31, 2010, between the Grantor and the Collateral Agent (the "Security Agreement"), the Grantor pledged, assigned and granted to the Collateral Agent a continuing security interest in all of its right, title and interest in and to certain collateral including, without limitation, the trademark registration set forth on Schedule I hereto along with the goodwill associated therewith (collectively, the "Trademark");

**WHEREAS**, the Security Agreement relating to the Trademark was recorded with the Trademark Division of the U.S. Patent & Trademark Office on April 14, 2010, at Reel 004185 and Frame 0382;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, solely as to the Trademark, the Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademark.


If and to the extent the Collateral Agent has acquired any right, title or interest to the Trademark, it hereby assigns and transfers such rights, title or interest to the Grantor.

The Collateral Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Grantor to more fully and effectively effectuate the purposes of this Release.
