INTENT-TO-USE TRADEMARK REGISTRATION APPLICATION ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns to Assignee all rights, title, and interest in and to the Trademark and the Registration Application therefor, together with any goodwill of the business connected with the use of and symbolized by the Trademark and the right to prosecute and recover monetary damages for past, present and future infringements and other violations of the Trademark.

FURTHER, Assignor agrees to execute and provide, promptly after its execution hereof, such further instruments, documents or assignments as may be reasonably requested by Assignee to effectuate the purposes of this transaction and to consolidate, vest and record in Assignee all of Assignor's rights in and to the Trademarks and the Registration Application.

IN WITNESS WHEREOF Assignor has executed this instrument.


