**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of March 4, 2011 (this "Release"), is made by Credit Suisse AG, Cayman Islands Branch (formerly Credit Suisse), as Collateral Agent ("Collateral Agent"), in favor of Maritime Telecommunications Network, Inc. ("Maritime") as follows:

**W I T N E S S E T H**

WHEREAS, pursuant to the Trademark Security Agreement dated May 11, 2006 (the "Security Agreement"), and recorded with The United States Patent and Trademark Office on August 23, 2006 at Reel/Frame No. 3385/0272, Maritime granted Collateral Agent a security interest in certain collateral described therein (the "Trademark Collateral");

WHEREAS, Maritime has requested that Collateral Agent release its security interest in and to the trademark registrations, including goodwill related thereto, set forth in Schedule A attached hereto.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, without recourse, representation or warranty and at Maritime's sole cost and expense, hereby (i) terminates, cancels and RELEASES all of its right, title and interest in and to the security interests granted to Collateral Agent pursuant to the Security Agreement in the Trademark Collateral, including each of the trademarks and trademark registrations set forth in Schedule A attached hereto and incorporated herein by reference and the registrations thereof and applications therefor, as applicable and (ii) re-assigns all of its right, title and interest in the Trademark Collateral to Maritime.

Collateral Agent agrees to provide Maritime with any information and additional authorization necessary to effect the release of Collateral Agent's security interest in the released Trademark Collateral and to take all further actions and provide to Maritime and its legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments reasonably requested by Maritime to more fully and efficiently effectuate the purposes of this Release. Collateral Agent hereby authorizes Maritime and its agents, attorneys and other designees to file this Release with the United States Patent and Trademark Office.
