**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE, dated as of March 4, 2011, from JPMorgan Chase Bank, N.A., a national banking association, as administrative agent (the "Administrative Agent") for the Secured Parties (as defined in the Credit Agreement referred to below, to General Nutrition Investment Company, an Arizona corporation (the "Grantor"), and each of entities listed on Schedule 1 hereto (collectively, with Grantor, the "Grantors").

WITNESSETH:

WHEREAS, pursuant to that certain Credit Agreement, dated as of March 16, 2007 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"; capitalized terms used herein but not defined herein have the meanings given such terms in the Credit Agreement), among GNC Corporation, a Delaware corporation, General Nutrition Centers, Inc., a Delaware corporation (the "Borrower"), the Lenders from time to time party thereto, J.P. Morgan Securities Inc. and Goldman Sachs Credit Partners L.P., as the Arrangers, Goldman Sachs Credit Partners L.P., as the Syndication Agent, the Administrative Agent, and Merrill Lynch Capital Corporation and Lehman Commercial Paper Inc., as the Documentation Agents, the Secured Parties agreed to extend credit to Borrower subject to the terms and conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, the Grantor entered into a Guarantee and Collateral Agreement, dated as of March 16, 2007, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement"), for the benefit of the Secured Parties;

WHEREAS, pursuant to the Guarantee and Collateral Agreement, a security interest (the "Security Interest") was granted by the Grantors to the Administrative Agent in certain Collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of March 16, 2007 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), made by the Grantors in favor of the Administrative Agent for the ratable benefit of the Secured Parties, Grantors, by reference to the Guarantee and Collateral Agreement, reaffirmed its intent to grant a Security Interest to the Administrative Agent specifically in the Trademark Collateral;

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on April 19, 2007 at Reel 3525 and Frame 9287; and



WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all outstanding Obligations and any other obligations, indebtedness and liabilities owing by the Grantors under the Loan Documents secured by the Trademark Collateral pursuant to the Guarantee and Collateral Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of any Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule 2 hereto. The term "Trademarks" shall mean: (i) all United States, state and foreign trademarks, service marks, trade names, corporate names, company names, business names, trade dress, trade styles, logos, or other indicia of origin or source identification, Internet domain names, trademark and service mark registrations, and applications for trademark or service mark registrations and any renewals thereof, (ii) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriates thereof, (iii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto, and (iv) all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each of the above.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Administrative Agent in such Trademark Collateral shall hereby cease, be of no further force or effect and become void.

3. Further Assurances. The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect, evidence or reflect of public record the release of the Security Interest contemplated hereby.
