RELEASE OF GRANT OF TRADEMARK SECURITY INTEREST

This **RELEASE OF GRANT OF TRADEMARK SECURITY INTEREST**, is made by Wells Fargo Bank, National Association (the "Secured Party"), effective as of March 3, 2011.

WHEREAS, VIP Sales Company, Inc. (now Discovery Foods, Inc.), an Oklahoma corporation ("Grantor"), granted to Secured Party a security interest in all of its right, title and interest in and to certain Trademark Collateral, as defined in the Grant of Trademark Security Interest, dated October 6, 2006 (the "Trademark Security Interest");

WHEREAS, the Trademark Security Interest was recorded at the United States Patent and Trademark Office on November 14, 2006 at Reel 3427 frame 0768; and

WHEREAS, the Secured Party desires to release its security interest in all of the Trademark Collateral, including without limitation, the trademark registrations and pending applications identified on Schedule A attached hereto.


NOW, THEREFORE, for valuable consideration, the Secured Party hereby terminates the Grant of Trademark Security Interest, and releases all right, title and interest it has in the Trademark Collateral, including without limitation, in the following:

1. all rights, title and interest (including rights acquired pursuant to a license or otherwise) in and to all trademarks, service marks, designs, logos, indicia, tradenames, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto, owned by said Grantor, or hereafter adopted and used, in its business (including, without limitation, the trademarks set forth on Schedule A annexed hereto) (collectively, the "**Trademarks**"), all registrations that have been or may hereafter be issued or applied for thereon in the United /States and any state thereof and in foreign countries (including, without limitation, the registrations and applications set forth on Schedule A annexed hereto), all common law and other rights (but in no event any of the obligations) in and to the Trademarks in the United States and any state thereof and in foreign countries, and all goodwill of such Grantor's business symbolized by the Trademarks and associated therewith ; and
2. all proceeds, products, rents and profits of or from any and all of the foregoing Trademark Collateral and, to the extent not otherwise included, all payments under insurance (whether or not Secured Party is the loss payee thereof), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the foregoing Trademark Collateral. For purposes of this Grant of Trademark Security Interest, the term "proceeds" includes whatever is receivable or received when Trademark Collateral or proceeds are sold, licensed, exchanged, collected or otherwise disposed of, whether such disposition is voluntary or involuntary.
