Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Article of Amendment to its Articles of Incorporation which changes the name of the Corporation

ARTICLE I

The name of the corporation is TimeVision, Inc

ARTICLE II

The following amendment to the Articles of Incorporation was adopted by the Shareholders of the corporation as of April 29, 2005

The amendment alters Article ONE of the Articles of Incorporation to read as follows
