(1) DEVRO, INC., a company incorporated under the laws of United States of America, of P O Box 11925, Sandy Run, Columbia, South Carolina 29211, United States of America, hereinafter referred to as "the Assignor"

and

(2) DEVRO PLC, Company No SC129785, of Moodiesburn, Chryston, Glasgow G69 OJE, United Kingdom, hereinafter referred to as "the Assignee"

Background

(A) The Assignor is the registered proprietor of the CORIA trade marks (hereinafter "the Trade Mark").

(B) The Assignor has agreed to assign to the Assignee the Trade Mark on the terms set out below.

Operative Clauses

1 In consideration for the sum of £1 now paid by the Assignee to the Assignor (receipt of which is hereby acknowledged by the Assignor), the Assignor hereby assigns to the Assignee its entire right, title and interest in and to the Trade Mark together with all goodwill in the business attached to the Trade Mark and the right to sue for past infringements and the right to retain any damages or other benefit as a result of such action.

2 The Assignor hereby covenants with the Assignee that the Assignor will at the expense of the Assignee execute, sign and do all such acts, documents, instruments, applications and things as may reasonably be required by the Assignee for the Assignee or the nominee of the Assignee to secure a full assignment of the Trade Mark hereby assigned.

3 This assignment shall be governed and construed in accordance with English law and the parties submit to the jurisdiction of the English courts.




