RELEASE OF SECURITY INTEREST

THIS TERMINATION AND RELEASE OF SECURITY INTEREST ("Release") is made and entered into as of this 8 day of March, 2011 by **Wells Fargo Credit, Inc.**, a Minnesota corporation ("Wells Fargo") and **Micro Dynamics Corporation**, a Minnesota corporation ("Micro Dynamics") (collectively the "Parties").

Wells Fargo hereby consents to and authorizes Micro Dynamics to file this Release with the USPTO to evidence the termination of any and all security interests, rights, titles, and interests Wells Fargo has or had under the Security Agreement with respect to U.S. Service Mark Registration No. 3,190,916 for the MICRO DYNAMICS mark.
