**FIRST AMENDMENT TO INTELLECTUAL PROPERTY  
SECURITY AGREEMENT**

**THIS FIRST AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "**Agreement**") is dated as of February 28, 2011, by and between **INET INTERACTIVE, LLC**, a Delaware limited liability company ("**Borrower**"), and **NORTHCREEK MEZZANINE FUND I, L.P.**, a Delaware limited partnership.

**WITNESSETH:**

**WHEREAS**, Borrower and Lender are parties to that certain Intellectual Property Security Agreement dated as of July 22, 2010 (the "**IP Security Agreement**"); capitalized terms used herein have the meanings given to them in the IP Security Agreement except as otherwise expressly defined herein); and

**WHEREAS**, Borrower, Lender and Stoddard Hill Media Holdings, LLC, a Delaware limited liability company ("**Stoddard Hill**"), have entered into that certain Note Purchase Agreement pursuant to which Borrower has granted to Lender additional security interests in certain intellectual property; and

**WHEREAS**, Borrower and Lenders desire to amend certain provisions of the IP Security Agreement in accordance with, and subject to, the terms and conditions set forth herein.

**NOW, THEREFORE**, in consideration of the premises, the covenants and agreements contained herein, and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Borrower and Lender hereby agree as follows:

A. **Acknowledgment of Obligations.** Borrower hereby acknowledges, confirms and agrees that all Obligations made prior to the date hereof, together with interest accrued and accruing thereon, and fees, costs, expenses and other charges owing by Borrower to Lender, are unconditionally owing by Borrower to Lender, without offset, defense or counterclaim of any kind, nature or description whatsoever except as may be limited by applicable bankruptcy, insolvency, reorganization, moratorium or other similar laws relating to or affecting creditor's rights generally and any and all security interests granted by Borrower in favor of Lender pursuant to the IP Security Agreement remain in full force and effect as of the date hereof.

B. **Amendments to Loan Agreement.** Subject to the terms and conditions of this Agreement, Schedules A, B, C, D, E and F of the IP Security Agreement are hereby amended by deleting them in their entirety and replacing each respective schedule with the corresponding schedule attached hereto.

C. **No Other Amendments.** Except for the amendments and agreements set forth and referred to in Section B above, the IP Security Agreement shall remain unchanged and in full force and effect. Nothing in this Agreement is intended, or shall be construed, to constitute a novation or an accord and satisfaction of any of Borrower's Obligations or to modify, affect or impair the perfection or continuity of Lender's security interests in, security titles to or other liens on any Collateral for the Obligations.

D. **Representations and Warranties.** To induce Lender to enter into this Agreement, Borrower does hereby warrant, represent and covenant to Lender that after giving effect to this Agreement (i) each representation or warranty of the Borrower set forth in the IP Security Agreement is hereby restated and reaffirmed as true and correct in all material respects on and as of the date hereof as if such representation or warranty were made on and as of the date hereof (except to the extent that any such representation or warranty expressly relates to a prior specific date or period) and (ii) Borrower has the power and is duly authorized to enter into, deliver and perform this Agreement and this Agreement is the legal, valid and binding obligation of the Borrower enforceable against the Borrower in accordance with its terms.

E. **Condition Precedent to Effectiveness of this Agreement.** This Agreement shall become effective as of the date (the "**Amendment Effective Date**") upon which the Borrower has satisfied each of the conditions specified below:

1. Lender shall have received one or more counterparts of this Agreement duly executed and delivered by the Borrower and Lender, in form and substance satisfactory to Lender; and
2. evidence of the satisfaction of each of the conditions precedent listed in Article 3 of that certain Note Purchase Agreement of even date herewith by and between Borrower, Lender and Stoddard Hill, which satisfaction shall be evidenced by the execution and delivery by Lender of a counterpart of this Agreement.

F. **Advice of Counsel.** Each of the parties represents to each other party hereto that it has discussed this Agreement with its counsel.

G. **Severability of Provisions.** In case any provision of or obligation under this Agreement shall be invalid, illegal or unenforceable in any applicable jurisdiction, the validity, legality and enforceability of the remaining provisions or obligations, or of such provision or obligation in any other jurisdiction, shall not in any way be affected or impaired thereby.

H. **Counterparts.** This Agreement may be executed in multiple counterparts, each of which shall be deemed to be an original and all of which when taken together shall constitute one and the same instrument.

I. **GOVERNING LAW.** THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE INTERNAL LAWS OF THE STATE OF OHIO APPLICABLE TO CONTRACTS MADE AND PERFORMED IN SUCH STATE WITHOUT REGARD TO THE PRINCIPLES THEREOF REGARDING CONFLICTS OF LAWS.

J. **Entire Agreement.** The IP Security Agreement as and when amended through this Agreement embodies the entire agreement between the parties hereto relating to the subject matter thereof and supersedes all prior agreements, representations and understandings, if any, relating to the subject matter thereof.

K. **No Strict Construction, Etc.** The parties hereto have participated jointly in the

negotiation and drafting of this Agreement. In the event an ambiguity or question of intent or interpretation arises, this Agreement shall be construed as if drafted jointly by the parties hereto and no presumption or burden of proof shall arise favoring or disfavoring any party by virtue of the authorship of any provisions of this Agreement. Time is of the essence for this Agreement.


