**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK, dated as of March 9, 2011 (the "Termination and Release"), from BANC OF AMERICA LEASING & CAPITAL, LLC, successor by merger to NATIONSCREDIT COMMERCIAL CORPORATION (the "Secured Party"), as agent for certain lenders that are parties, among others, to the Credit Agreement, dated as of August 6, 1997, to HERTZ CLAIM MANAGEMENT CORPORATION ("Hertz").

WHEREAS, Hertz owns the mark "HCM," which was registered with the U.S. Patent and Trademark Office (the "PTO") on April 9, 1996 under registration number 1,966,589 (the "Trademark");

WHEREAS, under the Trademark Security Agreement, dated as of August 6, 1997, between the Secured Party and Presidium, Inc. ("Presidium") (the "Trademark Security Agreement"), Presidium, as the prior owner of the Trademark, granted to the Secured Party a security interest (the "Security Interest") in the entire right, title and interest of Presidium in the Trademark;

WHEREAS, the Trademark Security Agreement supplemented the Security Agreement, dated as of August 6, 1997, between the Secured Party and Presidium (the "Security Agreement"), pursuant to which the Secured Party also had a Lien (as defined therein) in the Trademark;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the PTO on February 12, 1998 at reel 1688, frame 0692; and

WHEREAS, the Secured Party desires to terminate and release the entirety of its Security Interest and Lien in the Trademark effective as of March 9, 2011.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party agrees as follows:

1. Effective as of March 9, 2011, the Secured Party terminates, releases and discharges its Security Interest and Lien in the Trademark, and any right, title or interest of the Secured Party in the Trademark shall cease and become void.
2. Delivery of this executed Termination and Release by facsimile transmission or other customary means of electronic transmission (including "pdf") shall be effective as delivery of the Termination and Release signed manually.
