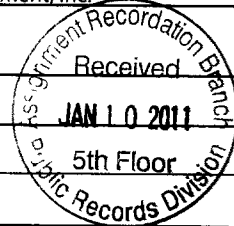

TERMINATION OF TRADEMARK SECURITY INTEREST

This TERMINATION OF TRADEMARK SECURITY INTEREST, dated as of November 3, 2010, is made by F.N.B. CAPITAL CORPORATION, LLC (the "Secured Party").

WHEREAS, Innovative Concepts in Entertainment, Inc. (the "Grantor") granted a security interest in certain personal property to the Secured Party, including without limitation a security interest in certain trademarks, trademark applications, and/or trademark licenses identified on Schedule A ("Trademarks") ;

WHEREAS, the security interest granted to the Secured Party was recorded at the United States Patent and Trademark Office on January 14, 2009 at Reel 003918 Frame 0689; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest in all of such Trademarks upon payment in full of all of the Obligations (as defined in that certain Note Purchase Agreement, dated June 9, 2008 among the Secured Party, ICE Acquisition Holding Corp. and Grantor).

NOW, THEREFORE, in consideration of payment in full of the Obligations, the Secured Party hereby terminates and releases all mortgages, liens, and security interests granted to the Secured Party in the following Trademarks:

1. all of the Grantor's Trademarks referred to on Schedule A attached hereto;
2. all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark, and any damages arising from past, present and future violations thereof.
