TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of June 28, 2010, by Dymas Funding Company, LLC ("Agent").

WITNESSETH:

WHEREAS, Lakeland Finance, LLC, a Delaware limited liability company ("Borrower"), entered into a Security Agreement dated as of September 24, 2004 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), in favor of Agent, in its capacity as administrative agent for certain secured parties identified therein (collectively, the "Secured Parties");

WHEREAS, pursuant to the Security Agreement, the Borrower granted to the Agent, for the benefit of the Agent and the Secured Parties a continuing Lien on all right, title and interest of the Borrower in, to and under certain intellectual property of Borrower, including the trademarks set forth on Exhibit A hereto, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "Trademarks"), to secure the prompt and complete payment, performance and observance of the Obligations (as such term is defined in the Security Agreement);

WHEREAS, Borrower acknowledged and confirmed such grant pursuant to that certain Intellectual Property Security Agreement – Trademarks, dated May 24, 2005, and recorded by the Assignment Division of the United States Patent and Trademark Office July 1, 2005, at Reel/Frame 003115/0800 (together with the Security Agreement the "IP Security Agreement");

WHEREAS, Borrower has satisfied all Obligations under the IP Security Agreement; and

WHEREAS, Borrower has requested that Agent release its security interest in the Trademarks and reassign same to Borrower.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged;

1. Agent, on behalf of itself and the Secured Parties (the "Releasers"), hereby releases its and their security interest in all of Releasers' right, title and interest in and to all of the Trademarks.

2. Releasers hereby reassign, grant and convey to Borrower, without any representation, recourse or undertaking by Releasers, all of Releasers' right, title and interest in and to the Trademarks.
