WHEREAS, Assignee, a Washington Corporation is desirous of acquiring said common law rights, registration, applications and the goodwill associated therewith;

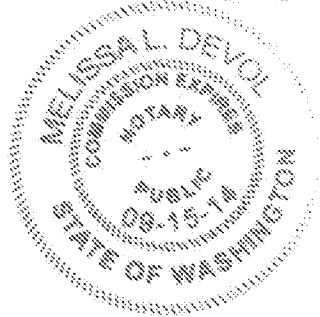
