RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of March 7, 2011, by COMERICA BANK, a Texas banking association ("Lender") in favor of NEWGISTICS, INC., a Delaware corporation ("Company") with its principal place of business located at 2700 Via Fortuna, Suite 300, Austin, TX 78746.

Recital

WHEREAS Company granted to Imperial Bank, predecessor in interest to Lender, a security interest in certain of the trademarks described on Exhibit A attached hereto under the terms of a security agreement dated as of May 15, 2000, and a security agreement dated as of December 28, 2000, (collectively, the "Prior Security Agreements") which were recorded with the US Patent and Trademark Office as set forth on Exhibit A.

WHEREAS Company additionally granted to Lender a security interest in the patents and certain of the trademarks described on Exhibits A and B attached hereto (collectively, the "Intellectual Property") under the terms of a Second Amended and Restated Intellectual Property Security Agreement dated as of February 14, 2006 (the "Existing Security Agreement") which was recorded with the US Patent and Trademark Office as set forth on Exhibits A and B.

WHEREAS Company and Lender are entering into a Fourth Amended and Restated Loan and Security Agreement (the "Loan Agreement"). Under and subject to the terms of the Loan Agreement, the Collateral as defined therein is being amended to delete intellectual property.

Agreement

Now therefore, Lender agrees that it terminates and releases its security interest in the Intellectual Property and reassigns to Company, without warranty or recourse, all interest of Lender in the Intellectual Property.
