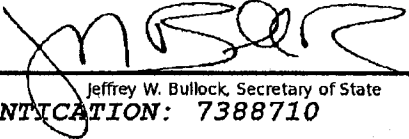

NOW, THEREFORE, BE IT RESOLVED, that this corporation merge into itself said Sharon Tube Company and assumes all of its liabilities and obligations;

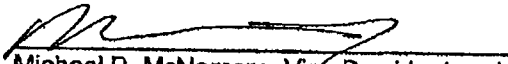
