**SUPPLEMENT
TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Supplement to Intellectual Property Security Agreement is entered into as of January 31, 2011 by and between SILICON VALLEY BANK ("Bank") and Talyst, Inc. ("Grantor").

RECITALS

A. Bank and Grantor previously entered into an Intellectual Property Security Agreement (the "IP Security Agreement") dated September 11, 2006.

B. Bank and Grantor now desire to amend and supplement the IP Security Agreement as set forth herein.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, the parties hereby represent, warrant, covenant and agree as follows:

AGREEMENT

The IP Security Agreement is hereby amended and supplemented by adding (1) the Exhibit A Supplement which is attached hereto (the "Exhibit A Supplement"), to Exhibit A of the IP Security Agreement; (2) the Exhibit B Supplement which is attached hereto (the "Exhibit B Supplement"), to Exhibit B of the IP Security Agreement; and (3) Exhibit C Supplement which is attached hereto (the "Exhibit C Supplement"), to Exhibit C of the IP Security Agreement. References to each of "Exhibit A", "Exhibit B" and "Exhibit C" contained in the IP Security Agreement shall be deemed to refer to Exhibit A as supplemented by the Exhibit A Supplement, Exhibit B as supplemented by the Exhibit B Supplement and Exhibit C as supplemented by the Exhibit C Supplement, respectively.


Without limitation on the generality of the foregoing, (i) Grantor grants and pledges to Bank a security interest in all of Grantor's right, title and interest in, to and under the intellectual property described on the Exhibit A Supplement, the Exhibit B Supplement and the Exhibit C Supplement (including without limitation the patents, trademarks and copyrights, if any, described thereon), and (ii) Grantor represents and warrants to Bank that, other than as set forth on Exhibit A (as supplemented by the Exhibit A Supplement), Exhibit B (as supplemented by the Exhibit B Supplement), and Exhibit C (as supplemented by the Exhibit C Supplement), it has no trademarks or patents registered with the United States Patent and Trademark Office, or copyrights registered with the United States Copyright Office, or any pending applications therefor.

This Agreement is part of the IP Security Agreement and the provisions thereof are incorporated herein. The parties are authorized to attach to the IP Security Agreement a copy of each of the Exhibit A Supplement, Exhibit B Supplement and Exhibit C Supplement. This Agreement may be executed in any number of, and by different parties hereto on, separate counterparts, all of which, when so executed, shall be deemed an original, for all such counterparts shall constitute one and the same agreement.
